**RE: Contact Record 2018-05 and RFLMA Attachment 2 Modification**

Dear Mr. Surovchak:

Thank you for the proposed Rocky Flats Site Regulatory Contact Record 2018-05 and Rocky Flats Legacy Management Agreement ("RFLMA") Attachment 2 with minor modifications ("RFLMA Mod"), submitted to the Colorado Department of Public Health and Environment ("CDPHE") and U.S. Environmental Protection Agency ("EPA") for review on November 7, 2018. Notably, the RFLMA Mod reflects updates to RFLMA Attachment 2 Practical Quantitation Limits, pursuant to CDPHE's Water Quality Control Division Practical Quantitation Limits ("PQLs") implementation policy ("PQL Policy," effective February 3, 2015).

CDPHE has reviewed and considered these documents; the evaluation methodology described in CR 2018-05; the Water Quality Control Division PQL Policy; the application of PQLs at other sites by the CDPHE Corrective Action Unit; and, multiple consultations with EPA and DOE. These minor modifications to correct RFLMA terminology and update tables will continue to ensure protection of human health and the environment as required by Paragraph 65 of RFLMA. The PQLs provided in Table 1 are consistent with the discussion held during our October 15, 2018 consultation meeting and the Water Quality Control Division's PQL Policy. Therefore, CDPHE approves this Contact Record 2018-05 and the RFLMA Mod dated November 7, 2018 and December 4, 2018<sup>1</sup>. Pursuant to Paragraph 66 and Section 7.0 of RFLMA, these documents shall be publicly posted by DOE.
