Finding of No Significant Impact

Environmental Assessment

The U.S. Department of Energy (DOE) proposes to conduct active ground water remediation at the Tuba City, Arizona, uranium mill tailings site. This proposed action and a no-action alternative are described in the *Environmental Assessment of Ground Water Compliance at the Tuba City Uranium Mill Tailings Site* (see attached DOE/EA 1268). The Environmental Assessment analyzes the relevant environmental issues at the Tuba City site, which include ground water, surface water, human health, air quality, wildlife, vegetation, soils, cultural resources, visual resources, socioeconomics, transportation, and environmental justice considerations.


The purpose of the proposed compliance action is to meet U.S. Environmental Protection Agency ground water standards that are defined in Title 40, Part 192 of the *U.S. Code of Federal Regulations* (40 CFR 192). Ground water at the Tuba City site is contaminated with residual radioactive material from historical activities associated with the processing of uranium ore. DOE is proposing to clean up the ground water by extracting it from the aquifer, treating it with a water distillation system, and injecting it back into the aquifer.

The *Programmatic Environmental Impact Statement for the Uranium Mill Tailings Remedial Action Ground Water Project* (PEIS) (DOE/EIS 0198) presents a step-by-step approach for determining the appropriate compliance strategy. That approach was used to select the ground water compliance strategy for the Tuba City site. The Environmental Assessment was tiered to the PEIS in a manner consistent with the concept of tiering described in 40 CFR 1508.28.

Finding

On the basis of the Environmental Assessment, which analyzes the relevant environmental issues and the concerns of stakeholders, DOE finds that no significant impact would result from implementing the proposed action to actively remediate ground water. This Finding of No Significant Impact is pursuant to the National Environmental Policy Act of 1969 (NEPA), 42 U.S. Code 4321 *et seq.*; the Council on Environmental Quality Regulations for Implementing the Procedural Provisions of NEPA, 40 CFR 1500; and the DOE National Environmental Policy Act Implementing Procedures, 10 CFR 1021. The proposed action does not constitute a major federal action that would significantly affect the environment within the mandate of NEPA. Therefore, implementation of the proposed action does not require an environmental impact statement.


