

Elimination of the Sites from the Formerly Utilized Sites Remedial Action SUBJECT: Program

TO: The File

In 1990, with the assistance of Mr. Doug Tonkay and Ms. Michelle Landis, I reviewed a number of sites that had formerly provided goods and/or services to the Fernald facility as subcontractors. For 24 of these sites, recommendations were made to eliminate them from further consideration under Formerly Utilized Sites Remedial Action Program (FUSRAP). In each case, I made or reviewed the evaluation, and, in each case, a handwritten evaluation was prepared. This is to provide a more formal record of the decision on these sites and to ratify and confirm the prior elimination of each site from FUSRAP.
