ADMINISTRATIVE RECORD INTRODUCTION

The documents contained in this administrative record (AR) were compiled by the U.S. Army Corps of Engineers (USACE) to identify appropriate remedial activities for use at the Linde Site under the Formerly Utilized Sites Remedial Action Program (FUSRAP). The AR reflects documents considered or relied upon in selecting the response action for contamination at the site. The AR also serves as a vehicle for public participation in selecting the response action. Documents reflecting this involvement are included in the AR.

The AR index (Attachment 1) is a subset of the permanent record and is sorted by filename. The filename is an alpha-numeric identification code unique to each document and is located on the first page of the document in the lower right-hand corner.

The AR was developed in accordance with the Comprehensive Environmental Response Compensation, and Liability Act (CERCLA) and USACE's FUSRAP Records Management Protocol and Quality Control Plan. This AR index was generated at the conclusion of the USACE's involvement at the site prior to transfer to the Department of Energy, Office of Legacy Management (DOE-LM). A review of the file for information protected by privilege, Privacy Act, or personally identifiable information was not completed. Should DOE-LM receive future Freedom of Information Act requests or other records requests, the document index and corresponding images should be evaluated for protected information prior to release.
