Subject: Painesville Site - Completion of Characterization Activities and Site Demobilization

Dear [REDACTED]

Bechtel, on behalf of the Department of Energy has completed its characterization activities at the Painesville site. A complete site demobilization from the Uniroyal Chemical Company (Uniroyal) property will occur by mid-November, including the removal of site office trailers and equipment. As part of this effort, the following activities will be performed by Bechtel to secure the site:

- 1) All electrical utilities will be de-terminated at the temporary power pole (distribution panel) with the exception of the underground service to Building 411. Service utilities (i.e., water and sewer) will be capped at ground level, marked, and remain in place after demobilization. These utilities will be used by site personnel when the site is remobilized for remedial action. Bechtel will construct a three foot high wood fence around the capped utilities to prevent maintenance vehicles from driving over these locations.
- 2) The shelving and lighting installed in Building 411 will remain in place after demobilization. Electricity will remain connected to Building 411, and Uniroyal will assume responsibility for electrical bill payments after Bechtel personnel have demobilized from the site on November 11, 1996.
- 3) The gravel access road to Building 411 and the gravel storage pad west of Building 411 will remain in place after demobilization. All damage grass areas will be seeded and strawed prior to demobilization.
- 4) An Investigation Derived Waste (IDW) storage area will be constructed in Building 411. This area will consist of at most four drums containing plastic and other contaminated (solids) items. The drums will be appropriately labeled and properly secured for storage. The IDW will be disposed when DOE personnel remobilize to the site for remedial action.
