By various emails, Weiss Associates on behalf of the Department of Energy (DOE) submitted the following reports:

- The 2016 Annual Land-Use Covenant (LUC) Inspection Report for DOE Areas (2016 LUC Report), dated January 2017 and submitted on January 10, 2017; and
- The 2017 Annual Land-Use Covenant Inspection Report for DOE Areas (2017 LUC Report), dated January 2017 and submitted on January 5, 2018.

The 2016 LUC Report and 2017 LUC Report (collectively, Reports) were submitted to the California Department of Toxic Substances Control (DTSC) and the United States Environmental Protection Agency (USEPA) to document the annual inspections of the property verifying compliance with the LUC for the 2016 and 2017 years, respectively, at the LEHR Site.
