Dear Mr. Shulte:

On September 28, 2012, the 45 day public comment period on End Cap Technologies, LLC ("End Cap") conceptual proposal to cap and close the Attleboro Landfill owned and formerly operated by Attleboro Landfill Incorporated ended. The Massachusetts Department of Environmental Protection ("MassDEP") has posted on its website all the public comments received on the conceptual proposal (webpage link: <http://www.mass.gov/dep/about/region/alicap.htm>) and has forwarded all comments to End Cap. MassDEP provides this letter in order to assist you in completing the public review and comment process on the conceptual proposal to close/cap the Phase B area in accordance with MassDEP's "Unlined Landfill Closure Policy" dated July 6, 2001 ("the Policy"), as amended.

MassDEP requests that End Cap submit a Response to Comments that will address the public comments. As you are aware, particular concern has been raised that the proposed transportation route is too constrained to support the truck traffic necessary to comply with the capping schedule and will create public safety, nuisance level conditions of air pollutants and potential impacts to abutting wetland resource areas. Without limiting the scope of the submission, the Response should comprehensively address these transportation-related concerns, including the feasibility of a rail option alternative. In addition, the submission should indicate End Cap's intention to maintain its current proposal, withdraw it or revise it including, if applicable, additional technical and/or financial information in support of a proposed revision.

MassDEP requests that End Cap within seven days from receipt of this letter communicate to the Department its proposed schedule to submit the above-described documents. Please contact
