1. This permit is good for 15 days only and must be on job at all times.
2. You must notify this office when openings are started and for backfill inspection (973) 881-4500.
3. Two lanes of traffic: one in each direction must be maintained during the hours of 7:00 A.M. to 9:00 A.M. and 3:00 P.M. to 6:00 P.M. weekdays.
4. WARNING: ROAD CANNOT BE CLOSED TO TRAFFIC AT ANY TIME.
5. If inspector is not present when backfilling takes place, Contractor must re-excavate the opening. Backfilling MUST BE DONE in the presence of the County Inspector.

This permit is granted on condition that the applicant shall perform all construction in compliance with the latest version of the "Manual on Uniform Traffic Control Devices" (MUTCD) as published by the U.S. Department of Transportation, Federal Highway Administration. Particular attention must be paid to Section VI - "Traffic Control for Street and Highway Construction, Maintenance, Utility and Emergency Operations." The applicant shall keep all excavations properly guarded, minimize interference to the traveling public, hold the County of Passaic harmless from all suits, and pay for all damages to public or private property resulting from the construction due to accidents or negligence. All excavations shall be filled in a manner directed by the County Inspectors. The above is in accordance with the "Right of Way Entry Passaic County Board of Chosen Freeholders, April 1, 1997.
